- 9:00 a.m. written exam will be administered
- 11:00 a.m. performance exam will be administered

\*\*Applicants are required to bring #2 pencils, proof of identification, and a non-programmable calculator. Programmable calculators or cell phones will not be allowed in the written exam.

<u>Registration is limited to the first 20 applicants</u>. It is very important to register as soon as possible so you have adequate time to receive and review study materials prior to the examination. The exam is based on information contained in ACI publication CP-1 40<sup>th</sup> Edition. All <u>RECERTIFICATIONS</u> require successful completion of both the written and performance portions of the exam.
